The development work will involve hands-on work alongside process engineers, production, quality and laboratory personnel.

The responsibilities include but are not limited to the following:

- Test raw materials and finished products for microbial contamination and other microbial tests.
- Prepare and sterilize culture media reagents as required.
- Timely completion of documentation and reports related to microbiological testing.
- Calibrate and maintain laboratory equipment.
- Validate procedures used in the micro lab.
- Identify needs and coordinate purchases of laboratory instruments.
- Set up new analytical instruments.
- Perform tests using High Performance Liquid Chromatography (HPLC).
- Write standard operating procedures and train relevant personnel in the operation of analytical instruments.
- Responsible for purchase, proper storage and maintenance of reference standards.
- Participate in QA related investigation as assigned by Manager.
- Ensure adherence with GMPs and SOPs for all activities in lab and ensure audit readiness of all labs.
- Report all out-of-specification or quality issues in a timely manner to Manager.
- Provide assistance in training other lab personnel on microbiological techniques and procedures.
- Review of documentation test results to assure material meets specifications.
- Interact effectively with co-workers and management in order to resolve problems.
- Produce high quality laboratory data.
- Ensures the proper manufacture and handling of trial batches as per customer's request.
- Generates and or adjusts mixing instructions and In Process Limits for customer products.
- Responsible for assisting the Product Development Manager in the specification of raw materials for and the formulation of vitamins, minerals and supplements as per customer specification.
